### Cookie Policy (EU)

This Cookie Statement was last updated on June 3, 2024 and applies to residents of the European Economic Area.

### 1. Introduction

https://www.natuurlijkharmonieusleven.nl (here in after: "the site") uses cookies and other related technologies. (In the following, all techniques are referred to as "cookies" for convenience). Cookies are also placed via third parties engaged by us. In the document below we inform you about the use of cookies on our site.

#### 2. What are cookies

A cookie is a simple small file that is sent along with pages from this site and stored by your browser on the hard drive of your computer or other device. The information stored there in can be sent back to our servers or those of the relevant third parties on a subsequent visit.

#### 3. What are scripts?

A script is a piece of program code that is used to run our website function and make it interactive. This code is executed on our server, or on your equipment.

#### 4. What is a web beacon?

A web beacon (or pixel tag) is a small, invisible piece of text or image on a site that is used to map traffic to a site. To do this, various information about you is stored with the help of web beacons.

#### 5. Cookies

#### 5.1 Technical or functional cookies

Some cookies ensure that certain parts of the site work properly and that your user preferences remain known. Placing functional cookies makes it easier for you to visit our site. You don't have to, for example, enter the same information over and over again when you visit our site and it is, among other things, possible that the items remain in your shopping cart until you have paid. We are allowed to place these cookies without your consent.

#### **5.2 Analytical cookies**

Because statistics are collected anonymously, no permission is requested for the placement of analytical cookies.

#### 5.3 Marketing/Tracking cookies

Marketing / tracking cookies are cookies or any other form of local storage that are used to create user profiles to display advertisements or to track the user on this site or across sites for similar marketing purposes.

7. Permission
